Applicant Representations and Assurances

In consideration for authorizing the appropriate utility company to install the gas meter(s) to the structure(s), the signatories below ("Applicants) agree to and understand the following:

- 1) The applicants Plumbing/Mechanical contractor and any of his/her licensed representatives shall at all times this permit is in effect be duly licensed.
- 2) This pre-gas meter application and permit is valid for commercial non-residential structure(s) only.
- 3) Approval of the pre-gas meter permit is valid for a maximum of 90 days from the date of approval.
- 4) The structure(s) will not be occupied until the certificate of occupancy or appropriate temporary certificate of occupancy has been issued. Applicants understand that if the building is occupied before a certificate of occupancy has been issued by the City Building Official, the City will have the right to direct the utility to terminate gas service without notice. Furthermore, Applicants understand and agree that should the Building Official exercise such right, the City of Morro Bay will not be responsible for any damage or cost which may result from the exercise of such right.
- 5) This pre-gas meter application must be completed, and fees collected. Attach a check or other acceptable form of payment for the full amount of the application filing fee established by resolution of the Morro Bay City Council pursuant to Morro Bay Municipal Code.
- 6) Applicants agree to permit the City Manager or his or her designee, and City building, fire and electrical inspectors, to conduct reasonable inspections of the premises, at the discretion of the City, for the purpose of ensuring compliance with this permit and all laws and regulations attendant to the work and mechanical/plumbing systems attendant to this permit, including but not limited to inspection of related security, inventory, and written records and files.
- 7) Applicants assume all risk and responsibility for proceeding with the work covered by this application.

8) *Applicants identified by this application and permit, being the undersigned, hereby agree to indemnify, defend and hold harmless (at Applicants' sole expense, joint and several, the ability to do so demonstrated through proof of sufficient insurance coverage to the satisfaction of the City) the City of Morro Bay, its elected officials, employees, agents, officers, and representatives, and each and all of them individually, from all liability or harm arising from or in connection with all claims, damages, attorney's fees, costs and allegations arising from or in any way related to the exercise of such rights as granted hereunder; and, to reimburse the City for any costs and attorney's fees that the City may be required to pay as a result of such action. Applicants agree that the City may, at its sole discretion, participate at its own expense in the defense of any such action.*
